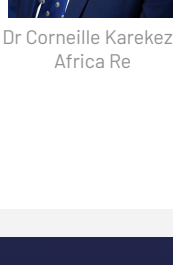

#### Africa Re is new Premium Content Partner of actuvew

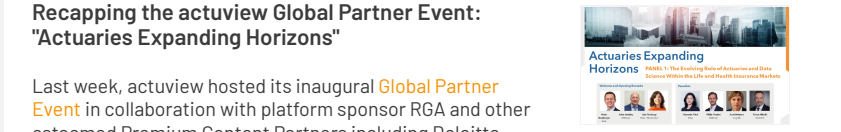

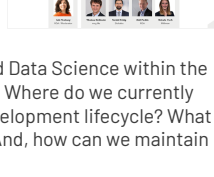

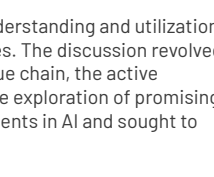


### Event Highlight

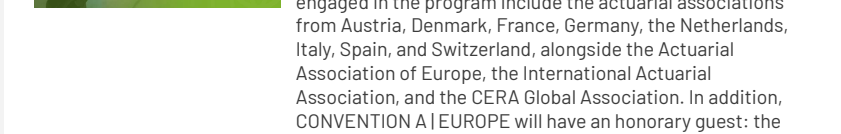

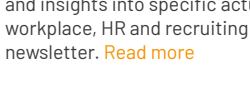
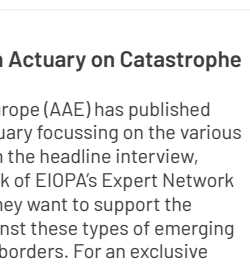


#### Various partners at the CONVENTION A | EUROPE

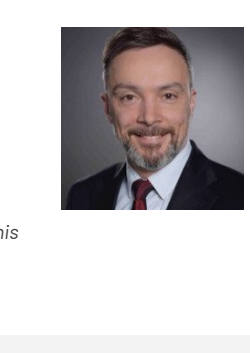


#### New issue of The European Actuary on Catastrophe Risks published

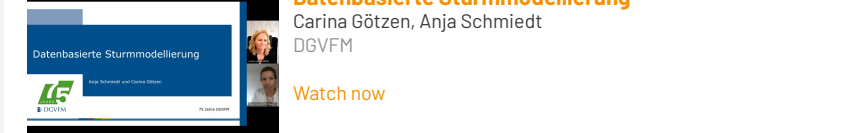
